2. The eligible bidders must have demonstratable experience and capacity (both technical and financial) to undertake the supply and delivery of the goods stated in this tender.
3. The eligible bidders must complete and submit the provided Price Schedule for Goods and Form of Tender alongside:
  - a) Certificate of Registration/Incorporation
  - b) KRA PIN Certificate
  - c) Valid Tax Compliance Certificate
  - d) A brief profile of the tenderer highlighting the last three (3) contracts performed with disclosure of the name of client, timing and value of each contract among other key details
